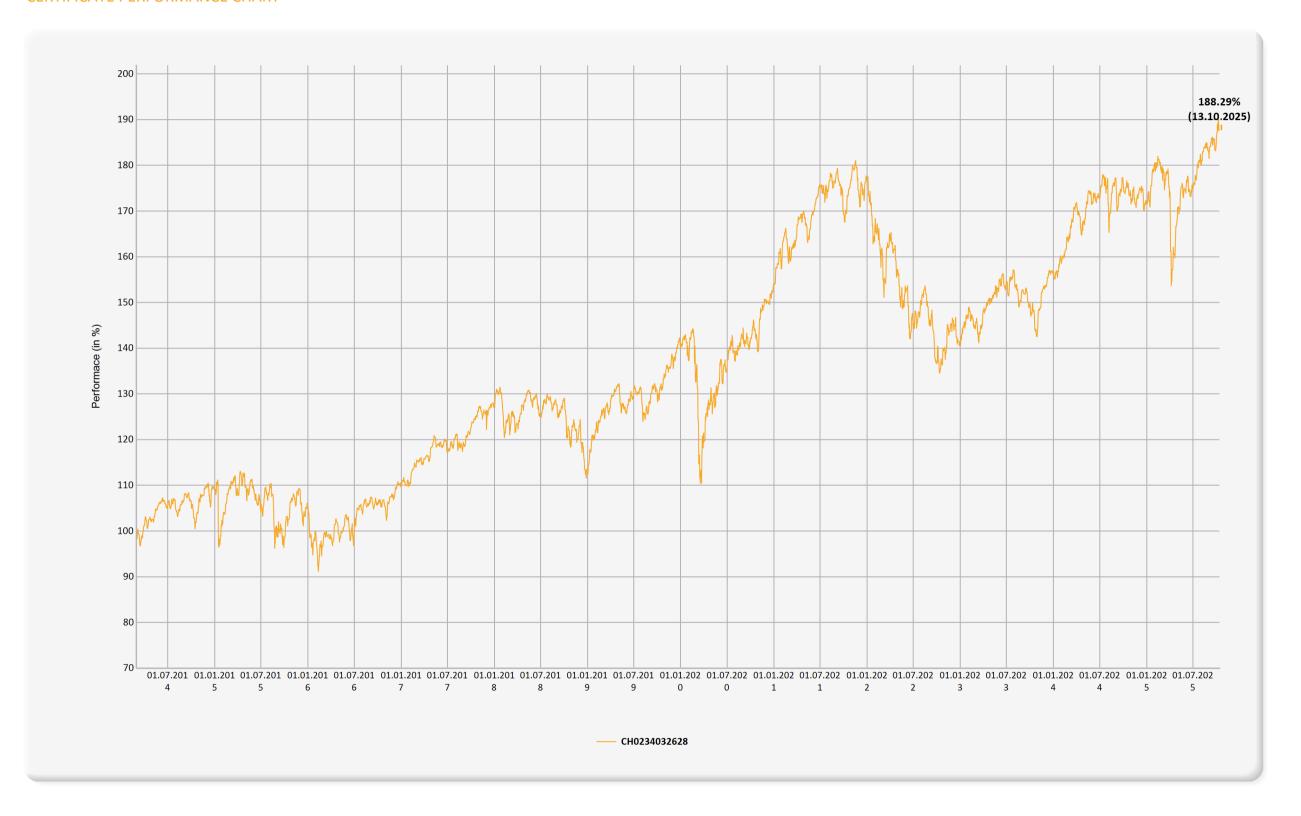

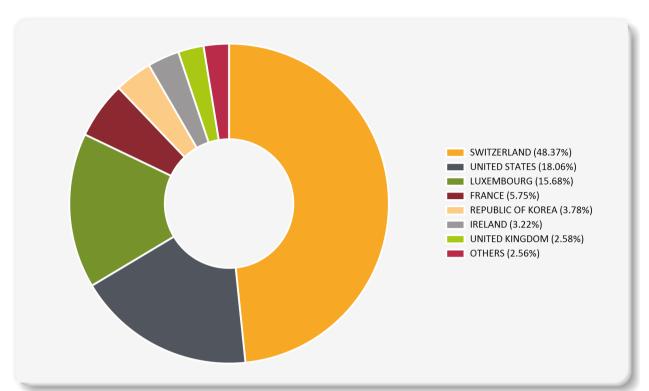

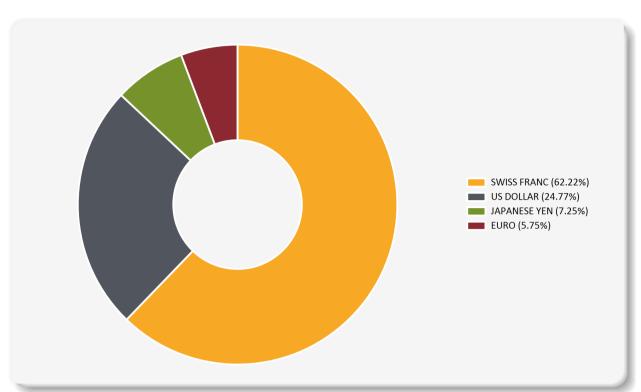
INDEX BREAKDOWN BY COUNTRY



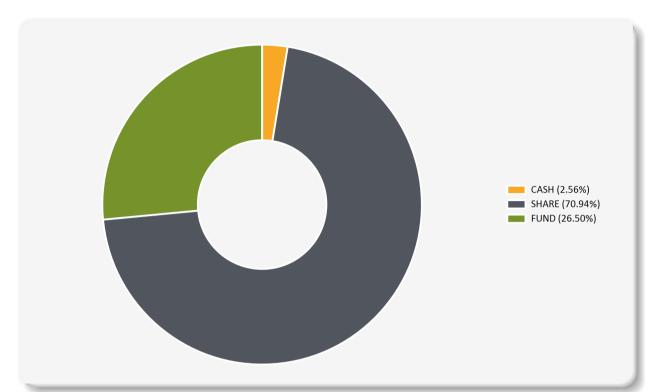

INDEX BREAKDOWN BY ASSET CLASS



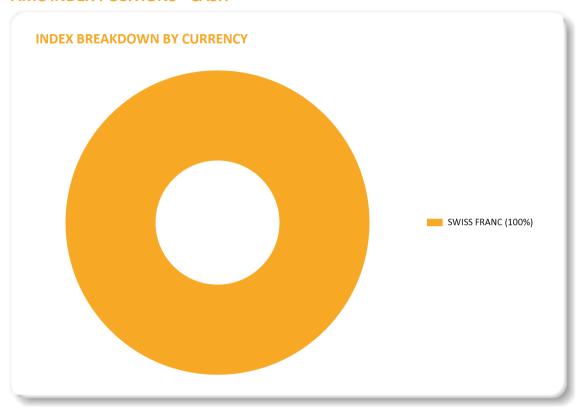
